

AN ORDINANCE 100716

ACCEPTING THE BIDS OF VARIOUS COMPANIES TO PROVIDE THE CITY OF SAN ANTONIO WITH THE VARIOUS TYPES OF COMMODITIES AND SERVICES ON AN ANNUAL CONTRACT BASIS FOR FISCAL YEAR 2005-2006 FOR AN ESTIMATED COMBINED ANNUAL COST OF \$443,270.00 TO INCLUDE CONTRACTS FOR TRUCK AND INDUSTRIAL TIRES, FLEX BEAMS AND ALLIED ITEMS, POLICE SEDAN ACCESSORIES AND SERVICES, PASSENGER TIRES, LIBRARY CASSETTE ALBUMS, MEDIA AND AUDIO SUPPLIES, AND PRINTING OF PASSES AND TICKETS.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, this group of contracts represents a portion of approximately two hundred and fifty (250) annual contracts that will be brought before City Council throughout the fiscal year; and

WHEREAS, these bids are from various companies to furnish the City with truck and industrial tires, flex beams and allied items, police sedan accessories and services, passenger tires, library cassette albums, media and audio supplies, and printing of passes and tickets; and

WHEREAS, Section I of the attachment consists of four (4) competitive bids in which awards are recommended to the lowest bidders; and

WHEREAS, Section II of the attachment consists of six (6) competitive bids in which awards are recommended to bidders other than the lowest bidders because the lowest bidders failed to meet the City's specifications and/or requirements; and

WHEREAS, all expenditures will be in accordance with the 2005-2006 budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The bids of various companies to furnish the City with truck and industrial tires, flex beams and allied items, police sedan accessories and services, passenger tires, library cassette albums, media and audio supplies, and printing of passes and tickets on an annual contract basis, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. All other bids will be considered rejected upon the successful bidder's completion of all conditions precedent to award or the expiration of sixty days from the effective date hereof, whichever occurs first. The bids and bid tabulation sheets are attached hereto and incorporated herein for all purposes as Attachment A.

SECTION 2. It has been found and declared that the low bid of A to Z Tire for item 4 for Passenger Tires, and the low bids of Printing Graphic Advertising of Texas, Inc. d/b/a The Graphic Arts Group and Rydin Decal for item 7 for printing of parking passes and tickets failed to meet the City's specifications.


SECTION 3. Funding will not be expended by this ordinance. All expenditures will be in accordance with the 2005-2006 budget approved by the City Council.
