

AN ORDINANCE **100778**

AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH BEXAR COUNTY AND AUTHORIZING THE RECOGNITION OF A CITY REPRESENTATIVE ON THE ALAMO REGIONAL MOBILITY AUTHORITY BOARD OF DIRECTORS; AS REQUESTED BY MAYOR EDWARD D. GARZA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, the Interim City Manager or the designee of either is hereby authorized to execute an agreement between the City of San Antonio and Bexar County "Providing For A City Seat On the Alamo RMA Board of Directors". A copy of the agreement is attached hereto and incorporated herein for all purposes as **Attachment I**. This agreement shall supersede any previous agreement between the parties relating to City representation on the AlamoRMA Board.

SECTION 2. This Ordinance confirms the City's recognition of Mr. Jim Reed as the City's current representative on the AlamoRMA Board.


SECTION 3. There is no financial impact associated with this Ordinance.

SECTION 4. However, the Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, assign allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.
