

AN ORDINANCE **100835**

AUTHORIZING THE SUBMISSION OF AN APPLICATION AND ACCEPTANCE OF A GRANT, IF OFFERED, FROM THE TEXAS DEPARTMENT OF HUMAN SERVICES FOR \$795,690.00 TO FUND THE 2005 SUMMER FOOD SERVICE PROJECT OPERATED BY THE DEPARTMENT OF PARKS AND RECREATION FOR THE PERIOD JUNE 6, 2005 THROUGH JULY 29, 2005.

**WHEREAS**, the City of San Antonio, through the Department of Parks and Recreation, has provided a Summer Food Service Program for the residents of San Antonio and Bexar County since 1969; and

**WHEREAS**, said program provides nutritional meals during the summer months to children age eighteen and below who would not otherwise have available the food assistance they receive during the school year through the National School Lunch and Breakfast Program; and

**WHEREAS**, the Department of Parks and Recreation operates this Summer Food Service Program in conjunction with the Summer Recreation Program; and

**WHEREAS**, it is now necessary to authorize the submission of an application for the Summer Food Service Program for 2005, establish a fund, approve a budget and personnel complement, and to authorize the acceptance of any additional food support funds received during the term of this grant; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**Section 1.** The Interim City Manager, or his designee is hereby authorized to submit an application to the Texas Department of Human Services for \$795,690.00 in funding for the 2005 Summer Food Service Program operated by the Department of Parks and Recreation.

**Section 2.** The Interim City Manager, or his designee is hereby authorized to accept the 2005 Summer Food Service Program grant when awarded and to execute such documents as the granting agency shall require in connection with this grant after review and approval by the City Attorney.

**Section 3.** Authorizing submission of grant application and acceptance, upon award, of funding from the Texas Department of Human Services in the amount of \$795,690.00 for

the 2005 Summer Food Service Project for the period of June 6, 2005 through July 29, 2005.

**Section 4.** Fund No. 26017000 has been established in SAP for the above said grant and the budget affixed hereto and incorporated herein for all purposes as Attachment II is approved.

**Section 5.** Upon award of funding, an SAP Internal Order, Cost Center and Functional Area will be established in Fund No. 26017000 for the above said grant.

**Section 6.** The budget of the Summer Food Service Project 2005, is hereby authorized to be revised to reflect any additional food support funds received from THDS during the term of this project.

**Section 7.** The financial allocations in this Ordinance are subject to approval by the Director of Finance of the City of San Antonio. The Director of Finance may, subject to concurrence by the Interim City Manager, or his designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**Section 8.** The seventeen (17) personnel positions set out in Attachment I and incorporated herein, are authorized for the Summer Food Service Project 2005.


**Section 9.** This ordinance shall be effective on and after May 22, 2005.


