

AN ORDINANCE 100902

ACCEPTING THE LOW, RESPONSIVE BID SUBMITTED BY SELRICO SERVICES, INC. TO PROVIDE THE CITY OF SAN ANTONIO PARKS & RECREATION DEPARTMENT WITH THE 2005 SUMMER FOOD SERVICE PROGRAM FOR AN ESTIMATED TOTAL COST OF \$554,279.63.

WHEREAS, bids were submitted to provide the City of San Antonio Parks & Recreation Department with the 2005 summer food service program; and

WHEREAS, this program is funded by a grant from the Department of Agriculture, administered by the Texas Health and Human Services Commission; and

WHEREAS, the low bid was submitted by Selrico Services, Inc. for a total amount of \$554,279.63; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Selrico Services, Inc. to provide the City of San Antonio Parks & Recreation Department with the 2005 summer food service program for an estimated total cost of \$554,279.63 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. Acceptance of this bid is also conditioned upon the approval of a grant application by the Texas Health and Human Services Commission, or other grant funding sources that may be made available therefore. Attached hereto and incorporated herein for all purposes as Attachment A is the bid and bid tabulation sheet.

SECTION 2. Funding in the amount of \$557,064.95 is approved, contingent upon grant award by the Texas Health and Human Services Commission, for purchase of lunch and snacks for an estimated 6,677 children in City of San Antonio Parks and Recreation Departments summer food service program as appropriated in existing SAP Fund 26020000, entitled "2005 Summer Food Program".

SECTION 3. The amount of \$557,064.95 will be encumbered upon issuance of a purchase order and made payable to Selrico Services, Inc. from SAP Fund 26020000, Internal Order No. 126000000148, GL Account # 5304010 entitled "Food".

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall take effect May 29th, 2005.


