

AN ORDINANCE

**ACCEPTING THE RESIGNATION OF PART-TIME MUNICIPAL COURT JUDGE GLORIA CABRERA AND APPOINTING JACK (JOHN) PASQUAL, III TO SERVE THE UNEXPIRED TERM ENDING JANUARY 17, 2006.**

**WHEREAS**, Judge Gloria Cabrera, a part-time Municipal Court Judge, resigned on March 7, 2005 and in response to its advertisement to fill the vacancy, the City received eight applications with six eligible for consideration under state and local law; and

**WHEREAS**, after due and careful consideration of all candidates and their applications at the May 3, 2005 and May 23, 2005 meetings, the Municipal Court Subcommittee of the Quality of Life Committee (the "Subcommittee") voted to recommend a qualified candidate from those applicants to the City Council to be appointed to fill the vacant position as a part-time Municipal Court Judge; and

**WHEREAS**, after due consideration of the Subcommittee's recommendation, the City Council has determined the candidate named in this ordinance should be appointed to fill the vacancy; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Council accepts the resignation submitted by Gloria Cabrera from her appointment and service as a part-time Municipal Court Judge, effective March 8, 2005.


**SECTION 2.** Jack (John) Pasqual, III is hereby appointed to serve the unexpired term ending January 17, 2006 as a part-time Judge for the City of San Antonio Municipal Court.


**SECTION 3.** The appointment made by this ordinance provides for all authority, compensation and benefits the City Council has previously established and that a current part-time Judge of the Municipal Court now holds and receives.

**SECTION 4.** Upon receipt of eight affirmative votes, this ordinance shall be effective immediately upon passage; otherwise, after the tenth (10th) day upon passage hereof.
