

AN ORDINANCE 100960

INCREASING THE SALARY OF LETICIA VACEK AS CITY CLERK AND PROVIDING THAT THIS ORDINANCE IS EFFECTIVE MAY 28, 2005 IF PASSED BY AT LEAST EIGHT VOTES.

WHEREAS, the City Charter provides that the City Clerk shall receive compensation as fixed by the City Council; and

WHEREAS, the City Council in Ordinance No. 99223 passed and approved on May 20, 2004, appointed Leticia Vacek to serve as City Clerk; and

WHEREAS, the City Council evaluated the performance of Leticia Vacek as City Clerk at its meeting on January 13, 2005, and

WHEREAS, the Governance Committee met on May 19, 2005 and recommended to increase her salary as City Clerk; **NOW, THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Pursuant to the provisions of Article II, Section 10 of the Charter of the City of San Antonio, the salary of Leticia Vacek as City Clerk of the City of San Antonio is fixed at \$100,857.76 per year effective May 28, 2005. The salary shall be paid to the City Clerk in bi-weekly payments, each of which shall be, as nearly as practicable, equal to one twenty-sixth (1/26) of the annual salary, on the schedule established for payment of salary to other city employees.

SECTION 2. All other provisions of ordinances establishing terms and conditions of the employment of Leticia Vacek as City Clerk remain in effect except as provided herein.

SECTION 3. This ordinance shall take effect on May 28, 2005, if approved by eight (8) or more affirmative votes; otherwise, this ordinance shall be effective on and after the tenth (10th) day from the date of passage hereof.
