

AN ORDINANCE 100959

INCREASING THE ANNUAL SALARY PAID AND LEAVE ACCRUAL TO PATRICIA M. MAJOR AS CITY AUDITOR AND PROVIDING THAT THIS ORDINANCE IS EFFECTIVE MAY 28, 2005 IF PASSED BY AT LEAST EIGHT VOTES.

WHEREAS, the City Charter provides that the City Auditor shall receive compensation as fixed by the City Council; and

WHEREAS, the City Council in Ordinance No. 97120 passed and approved on January 30, 2003, appointed Patricia M. Major to serve as City Auditor; and

WHEREAS, the City Council evaluated the performance of Patricia M. Major as City Auditor at its meeting on January 27, 2005, and

WHEREAS, the Governance Committee met on May 19, 2005 and recommended to increase her annual salary paid and leave accrual as City Auditor; **NOW, THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Pursuant to the provisions of Paragraph 2 of Article V.A. of the Charter of the City of San Antonio, the salary of Patricia M. Major as the City Auditor of the City of San Antonio is fixed at \$116,698.94 per year effective May 28, 2005. The City Auditor shall accrue annual leave according to established procedures at the rate of twenty-two (22) days per year. The salary shall be paid to the City Auditor in bi-weekly payments, each of which shall be, as nearly as practicable, equal to one twenty-sixth (1/26) of the annual salary, on the schedule established for payment of salary to other city employees.

SECTION 2. All other provisions of ordinances establishing terms and conditions of the employment of Patricia Major as City Auditor remain in effect except as provided herein.

SECTION 3. This ordinance shall take effect on May 28, 2005, if approved by eight (8) or more affirmative votes; otherwise, this ordinance shall be effective on and after the tenth (10th) day from the date of passage hereof.
