AMENDING THE CITY OF SAN ANTONIO'S THREE YEAR ANNEXATION PLAN BY ADDING THE TIMBERWOOD PARK AREA AND CERTAIN ADJACENT PROPERTY THAT CONSISTS OF APPROXIMATELY 4,345 ACRES.

WHEREAS, Chapter 43 of the Texas Local Government Code provides that a City shall adopt a municipal annexation plan to identify areas that may be annexed by the City on and after January 1, 2003; and

WHEREAS, the City Council of the City of San Antonio adopted a three year annexation plan in accordance with Chapter 43 of the Texas Local Government Code on September 19, 2002; and

WHEREAS, the City Council of the City of San Antonio amended the plan on December 12, 2002, and July 22, 2004; and

WHEREAS, the Planning Commission of the City of San Antonio recommended adoption of the amendment at its May 25, 2005 meeting; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO

SECTION 1. The Three Year Annexation Plan of the City of San Antonio is amended to include the Timberwood Park area and certain adjacent property which consists of approximately 4,345 acres as more particularly described and shown in **Exhibit A**, which is attached hereto and incorporated herein for all purposes. The City of San Antonio may annex the area more specifically identified in said Exhibit A of this resolution as permitted by law

SECTION 2. This resolution is effective immediately if it receives eight affirmative votes. Otherwise, it is effective on June 5, 2005.
