

AN ORDINANCE

**DESIGNATING EACH MEMBER OF THE CITY COUNCIL  
AS MAYOR PRO TEM FOR A SPECIFIED PERIOD  
DURING THE 2005-2007 TERM.**

**WHEREAS**, Section 9 of the City of San Antonio City Charter provides for a Mayor Pro Tem to act as Mayor during the absence or disability of the Mayor; and

**WHEREAS**, a tradition has been established of rotating the Mayor Pro Tem position among all of the members of the Council, other than the Mayor, during the two-year term;  
**NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The following named members of the City Council are hereby designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:

June 23, 2005 through September 2, 2005	Art A. Hall
September 3, 2005, through November 13, 2005	Roger O. Flores
November 14, 2005 through January 24, 2006	Elena Guajardo

**SECTION 2.** Council Member Art Hall, District 8, is hereby sworn in as Mayor Pro Tem for the period beginning June 23, 2005 through September 2, 2005.

**SECTION 3.** Should any of the above Council Members be replaced for any reason, such replacement shall be substituted for such member for the term indicated.

**SECTION 4.** This ordinance shall take effect on June 23, 2005, if approved by eight (8) or more affirmative votes; otherwise, said ordinance shall be effective on and after the tenth (10<sup>th</sup>) day from the date of passage hereof.
