

AN ORDINANCE 101288

APPROVING THE TEMPORARY STREET CLOSURE OF GUADALUPE STREET BETWEEN SOUTH BRAZOS STREET AND SOUTH SAN JACINTO STREET IN CONNECTION WITH THE ANNUAL GUADALUPE STREET PARADE AND CALLE GUADALUPE FESTIVAL TO BE HELD FROM 9:00 A.M. ON SATURDAY, SEPTEMBER 10, 2005 TO 6:00 A.M. ON SUNDAY, SEPTEMBER 11, 2005, SPONSORED BY THE AVENIDA GUADALUPE ASSOCIATION, INC.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The temporary street closure of Guadalupe Street between South Brazos Street and South San Jacinto Street from 9:00 a. m. on Saturday, September 10, 2005 to 6:00 a. m. on Sunday, September 11, 2005 as requested by the Avenida Guadalupe Association, Inc. in order to hold its annual "Guadalupe Street Parade and Calle Guadalupe Festival" is hereby authorized. The City finds that granting this request will promote the health, safety, and welfare of the participants and the public in the vicinity.

SECTION 2. The City Manager or his designee, is authorized to further implement this ordinance by taking any additional actions deemed necessary to protect the public.

SECTION 3. Funds in the amount of \$150.00 are authorized to be deposited in Fund 11001000 entitled "General Fund", Internal Order Number 223000000163 entitled TRAFFIC - PARADE/BLOCK PARTY BARRICADE, General Ledger 4401270 entitled Svc Charge - Street Closures and Events when received.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance for the City of San Antonio for the City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. The Avenida Guadalupe Association, Inc. shall be responsible for the following: a) fulfilling all insurance requirements, paying the required street closure permit fee and any other fees and license charges; b) posting signs, barricades and the use of any off duty or on-duty police officers, as may be required by the City of San Antonio's Public Works and/or Police Departments; c) evidencing the street closure to provide for the safety of patrons and the rerouting of traffic; and d) cleaning the area up after the event is held.

SECTION 6. The Avenida Guadalupe Association, Inc. agrees to assume all risks inherent in this event and shall indemnify and hold harmless the City of San Antonio from any and all costs, damages, injuries, or losses attendant to, or in any way growing out of this special use of the public street rights of way.

SECTION 7. This ordinance shall be effective on September 4, 2005.
