AN ORDINANCE

AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO NEGOTIATE A DESIGN-BUILD CONTRACT WITH ZACHRY CONSTRUCTION CORPORATION, BARLETT COCKE, L.P., OR SPAW GLASS CONSTRUCTORS, INC. FOR THE EMERGENCY OPERATIONS CENTER AT BROOKS-CITY BASE IN COUNCIL DISTRICT 3.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or his designee is authorized to negotiate a design build agreement with Zachry Construction Corporation ("Zachry") in accordance with the proposal submitted for design and construction of the Emergency Operations Center ("EOC"). The City Manager or his designee is further authorized to negotiate a design-build agreement with the second ranked firm, Bartlett Cocke, L.P., or the third ranked firm of Spaw Glass Constructors, Inc., as necessary, in the event negotiations with Zachry are unsuccessful.

SECTION 2. There is no fiscal impact with this Ordinance.

SECTION 3. This Ordinance shall take effect on August 28, 2005.


