

AN ORDINANCE 101364

**AUTHORIZING THE TEMPORARY CLOSURE OF KENTUCKY AVENUE BETWEEN N. ELMENDORF AND N. ZARZAMORA FROM 12:01 A. M. ON SATURDAY, OCTOBER 8, 2005 TO 11:30 P. M. ON SUNDAY, OCTOBER 9 FOR THE ANNUAL CHURCH FESTIVAL SPONSORED BY THE BASILICA OF THE NATIONAL SHRINE OF THE LITTLE FLOWER.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The temporary street closure of Kentucky Avenue between N. Elmendorf and N. Zarzamora from 12:01 a. m. on Saturday, October 8, 2005 to 11:30 p. m. on Sunday, October 9, 2005, as requested by the **Basilica of the National Shrine of the Little Flower**, in order to hold their annual "**Church Festival**" is hereby authorized

**SECTION 2.** The City Manager or his designee, is authorized to further implement this ordinance by taking any additional actions deemed necessary to protect the public.

**SECTION 3.** Funds in the amount of \$150.00 are authorized to be deposited in Fund 11001000 entitled "General Fund", Internal Order Number 223000000163 entitled TRAFFIC - PARADE/BLOCK PARTY BARRICADE, General Ledger 4401270 entitled Svc Charge - Street Closures and Events when received.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance for the City of San Antonio for the City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 5. The Basilica of the National Shrine of the Little Flower** shall be responsible for the following: a) fulfilling all insurance requirements, paying the required street closure permit fee and any other fees and license charges; b) posting signs, barricades and the use of any off duty or on-duty police officers, as may be required by the City of San Antonio's Public Works and/or Police Departments; c) evidencing the street closure to provide for the safety of patrons and the rerouting of traffic; and d) cleaning the area up after the event is held.

**SECTION 6. The Basilica of the National Shrine of the Little Flower** shall assume all risks inherent in this event and shall indemnify and hold harmless the City of San Antonio from any and all costs, damages, injuries, or losses attendant to, or in any way growing out of this special use of the public street rights of way.

**SECTION 7.** This ordinance shall be effective on September 18, 2005.


