AN ORDINANCE

**AUTHORIZING CLOSURE, VACATION AND ABANDONMENT OF AN UNIMPROVED PORTION OF LISBON DRIVE LOCATED BETWEEN OAK (ALSO KNOWN AS SILVER OAKS) AND ANCHOR DRIVES AND NCB'S 11733 AND 11737 IN DISTRICT 9 FOR THE TOTAL CONSIDERATION OF \$14,659.00**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Subject to the reservation of Section 2, the City finds the following right-of-way surplus to its needs and hereby closes, vacates, and abandons it: That portion of Lisbon Drive lying between Anchor Drive on the southwest and Oak Drive (also known as Silver Oaks) on the northeast and also lying between New City Blocks 11733 and 11737.

**SECTION 2.** This ordinance does not release any public rights in the subject tract for drainage, water and wastewater lines, electric transmission lines, communication lines of all types, or any other rights except for the right of the public to travel on the subject tract.

**SECTION 3.** The City Manager or his designee is authorized and directed to execute and deliver all documents and to do all other things necessary or convenient to reflect this closure, abandonment, and vacation.

**SECTION 4.** Funds in the amount of \$14,659.00 are to be deposited into fund 29027000, Special Revenue Reserve; IO 22400000010, Sale of Land; General Ledger 4903101, Sales-Land; when received from petitioner, First Church of the Nazarene.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance for the City of San Antonio for the City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This ordinance shall become effective October 16, 2005.


