

AN ORDINANCE **101412**

**AUTHORIZING EXECUTION OF NECESSARY CONTRACTS TO PROVIDE THIRD PARTY CLAIMS ADMINISTRATION AND MEDICAL COST CONTAINMENT SERVICES FOR THE CITY'S SELF INSURED WORKERS' COMPENSATION AND LIABILITY PROGRAM.**

**WHEREAS**, the City of San Antonio ("City") Department of Human Resources released a Request for Proposals ("RFP") to provide Third Party Claims Administration and Medical Cost Containment services for the City's self-insured workers' compensation and liability program on July 16, 2005; and

**WHEREAS**, the Third Party Administrator processes, investigates, adjusts, negotiates, and pays claims in accordance with the requirements of the Texas Worker's Compensation Act and the Texas Tort Claims Act; and

**WHEREAS**, this contract will also provide for medical cost containment services, including, but not limited to, medical bill review, hospital bill audits, occupational provider network, pre-authorizations, utilization reviews, peer reviews, vocational and rehabilitation evaluation, discharge planning, and case management; and

**WHEREAS**, Staff recommends CMI Barron Risk Management Services, Inc. to provide said services; **NOW THEREFORE**:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** CMI Barron Risk Management Services, Inc. ("CMI") is hereby selected to provide Third Party Administration and Medical Cost Containment services for a period commencing on October 1, 2005 and ending on December 31, 2006, for a cost not to exceed \$2,360,000.00. The City Manager, or the City Manager's designee, is authorized to execute a contract with CMI in substantially final form as set forth in Exhibit A, which is attached hereto and incorporated herein for all purposes. The Scope of Services to be provided by CMI are as set forth in City's Request for Proposal and CMI's Proposal. The terms of said contract are hereby approved.

**SECTION 2.** The amount of \$832,640.00 is authorized to be appropriated and encumbered in Fund 75-001000, Insurance Reserve Fund, in G/L 5201040, Fees to Professional Contractors, in Cost Center 1009020001, and made payable to CMI Barron Risk Management, for administrative services beginning on October 1, 2005 and ending on December 31, 2006.


**SECTION 3.** The amount of \$1,248,960.00 is authorized to be appropriated and encumbered in Fund 75-003000, Workers' Compensation Fund, in G/L 5201040, Fees to Professional Contractors, in Cost Center 1009040001, and made payable to CMI Barron Risk Management, for administrative services beginning on October 1, 2005 and ending on December 31, 2006.


**SECTION 4.** The amount of \$278,400.00 is authorized to be appropriated and encumbered in Fund 75-003000, Workers' Compensation Fund, in G/L 5201040, Fees to Professional Contractors, in Cost Center 1009040001, and made payable to CMI Barron Risk Management, for cost containment expenses for the period beginning October 1, 2005 and ending December 31, 2006.


**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director, may subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This ordinance shall take effect October 1, 2005.
