

AN ORDINANCE 101593

AUTHORIZING THE EXECUTION OF A CONTRACT CHANGE FOR AN ADDITIONAL \$16,667.00 FROM THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES (TDSHS) TO AUGMENT FUNDING FOR THE TITLE X FAMILY PLANNING PROGRAM 2004/2005 OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT (SAMHD) AND EXTEND THE PERIOD FROM AUGUST 31, 2005 TO DECEMBER 31, 2005; REVISING THE PROGRAM BUDGET; AND AUTHORIZING PAYMENTS FOR CONTRACTUAL SERVICES.

WHEREAS, the Texas Department of State Health Services (TDSHS) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

WHEREAS, these services include a variety of activities including family planning services for Title X eligible individuals; and

WHEREAS, Ordinance No. 98536, passed and approved on December 4, 2003, authorized the execution of Contract 7460020708 2005 between the City of San Antonio and TDSHS, covering operation of the Public Health State Support Project 2004/2005 of the SAMHD; and

WHEREAS, TDSHS has now offered an additional \$16,667.00 to augment support for the Title X Family Planning Program 2004/2005 through Contract Change Notice No. 29, Attachment 14B, to the above contract and extend the period to December 31, 2005; and

WHEREAS, the balance of the funds required for this program will come from Title X patient co-payments; and

WHEREAS, it is now necessary to authorize the acceptance of the additional support from TDSHS, approve the execution of the contract change, revise the program budget, and authorize payments for contractual services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or his designee, is authorized to accept and execute Contract Change Notice No. 29, Attachment 14B to Grant Contract 7460020708 2005 with TDSHS to accept an additional \$16,667.00 to augment support for the Title X Family Planning Program 2004/2005 in the SAMHD for the period September 1, 2004 through December 31, 2005. A copy of Contract Change Notice No. 29 is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. Fund 26016000, Funds Center 3606330000, Cost Center 3606330001, Internal Order 136000000246 entitled "2004-05 Title X Family Planning", is hereby designated for use in accounting for the fiscal transactions of this project.

SECTION 3. The additional sum of \$16,667.00 for this project is hereby appropriated in the above-designated fund, GL Account No. 4501100, entitled "Grants from Federal Agencies – Operating," and budget set out in Attachment II is approved and adopted for entry on the City books.

SECTION 4. Co-payments obtained from patients receiving services through the Title X Family Planning Program 2004/2005 will be deposited into Fund 26016000, Funds Center 3606330000, Cost Center 3606330001, Internal Order 136000000246, SAP GL Account No. 4502230 entitled "Grants Program Income Operating."

SECTION 5. Payments in an aggregate amount of \$14,259.00 are hereby authorized to be paid from Fund 26016000, Funds Center 3606330000, Cost Center 3606330001, Internal Order 136000000246, SAP GL Account No. 5201040, Fees to Professional Contractors, on a fee for service basis to various contract professional licensed physicians and registered nurses to cover the services of those medical professionals who see patients in the SAMHD family planning clinics.

SECTION 6. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific fund numbers, internal order numbers, and SAP GL numbers as necessary to carry out the purpose of this ordinance.

SECTION 7. Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

SECTION 8. This ordinance shall be effective on and after October 30, 2005.

It is mutually agreed by and between the contracting parties to amend the conditions of Document No. 7460020708 2005 -14A as written below. All other conditions not hereby amended are to remain in full force and effect.

SECTION I. SCOPE OF WORK, sixth paragraph, is replaced with the following:

PERFORMANCE MEASURES

The following performance measures will be used to assess, in part, the PERFORMING AGENCY'S effectiveness in providing the services described in this contract Attachment, without waiving the enforceability of any of the terms of the contract.

PERFORMING AGENCY shall provide family planning medical services to 1,242 unduplicated clients who live or receive services in the following county(ies)/area: Bexar. The services shall be provided to the clients in the following population categories and in the following numbers:

Performance measure data shall be reported in the annual Progress Report (Objectives) no later than 60 days after the end of the Attachment term.

SECTION I. SCOPE OF WORK is revised to include the following:

PERFORMING AGENCY shall perform no elective abortion procedures, shall neither contract with nor provide funds to any individual or entity for the performance of elective abortions, and

shall submit no claims to RECEIVING AGENCY for reimbursement of direct or indirect costs (including overhead, rent, phones, and utilities) of abortion procedures.

If PERFORMING AGENCY is affiliated with an entity that performs elective abortion procedures or becomes affiliated with an entity that performs elective abortions at any time during the term of this contract,

1. PERFORMING AGENCY and its abortion-services affiliate must be legally separate corporations, with separate articles of incorporation and separate bylaws. If PERFORMING AGENCY is a State or local governmental entity, the abortion-services affiliate must be a legally separate organization with a separate governing structure.
2. PERFORMING AGENCY and its abortion-services affiliate must have easily distinguishable names.
3. PERFORMING AGENCY and its abortion-services affiliate must have separate boards of directors or governing bodies which meet separately and maintain separate records.
4. PERFORMING AGENCY may not transfer any funds distributed under RECEIVING AGENCY Strategy B.1.3 to its abortion-services affiliate. PERFORMING AGENCY must assure that its affiliated entity apportions fair value for any shared expenses or costs (including overhead, rent, phones, equipment, and utilities) in accordance with generally accepted accounting principles.
5. PERFORMING AGENCY shall assure that any person employed part-time by PERFORMING AGENCY and by its abortion-services affiliate shall contemporaneously maintain accurate time records, similar to time records maintained by attorneys, though not necessarily by means of an automatic recording device such as a "time clock", that clearly reflect the work performed for each employer.
6. If PERFORMING AGENCY and its abortion-services affiliate are located at the same physical location, PERFORMING AGENCY shall assure that the existence and separate nature of the affiliate relationship is clearly reflected by appropriate signage in areas accessible to the public.
7. PERFORMING AGENCY and its abortion-services affiliate must each maintain records adequate to show compliance with the foregoing requirements.

SECTION II. SPECIAL PROVISIONS is revised to include the following:

RECEIVING AGENCY shall include in any financial audits of state funds received by PERFORMING AGENCY under this attachment a review to ensure compliance with the requirements of Department of State Health Services Rider 30, General Appropriations Act, 79th Legislature.

SECTION II. SPECIAL PROVISIONS, page 4, **Reports** Article, first paragraph, is replaced with the following:

PERFORMING AGENCY shall provide the following routine reports to RECEIVING AGENCY in compliance with the dates and conditions specified below:

SECTION II. SPECIAL PROVISIONS, **Reports** Article, sixth paragraph, is replaced with the following:

DATA COLLECTION - PERFORMING AGENCY shall maintain statistical and management information systems that are compatible with accurate reporting of contract performance under Family Planning Annual Report (FPAR). PERFORMING AGENCY shall submit encounters, including reports of all Family Planning services provided, for all individual medical services provided to clients during any given encounter submission period. Encounters shall be submitted to Texas Medicaid and Healthcare Partnership (TMHP) from September 1, 2005 through December 31, 2005, in a manner compatible with the Compass 21 billing and reporting system. Encounters shall be submitted by the 60th day after the date on which services were provided. Encounters shall be submitted using approved claim/encounter format, which follows the RECEIVING AGENCY Program specifications which may be obtained from RECEIVING AGENCY Program.

General Provisions, **Child Abuse Reporting Requirements** Article, first sentence, is replaced in its entirety:

PERFORMING AGENCY is required to comply with this article only as related to services provided under the following Attachments: Human Immunodeficiency Virus and Sexually Transmitted Diseases (all direct client care services for HIV and other sexually transmitted

diseases funded under the Ryan White CARE Act Title II or general revenue), Title V Family Planning (CHS/FEE-FP), Title X Family Planning (CHS/TITLE X), Title XX Family Planning (CHS/TTLXX), Primary Health Care (CHS/PHC), Title V Maternal and Child Health (CHS/FEE), Special Supplemental Nutrition Program for Women, Infants, and Children (NSS/WIC-CARD), and the Services Delivery Integration project (SDI/FFS).

General Provisions, **Terms and Conditions of Payment** Article, is revised to include the following:

shall submit no claims to RECEIVING AGENCY for reimbursement of direct or indirect costs (including overhead, rent, phones, and utilities) of abortion procedures.

If PERFORMING AGENCY is affiliated with an entity that performs elective abortion procedures or becomes affiliated with an entity that performs elective abortions at any time during the term of this contract,
