**ALLOCATING THE VOTES FOR THE CITY'S CANDIDATE FOR  
THE BEXAR APPRAISAL DISTRICT BOARD OF DIRECTORS**

**WHEREAS**, the Bexar Appraisal District Board of Directors is comprised of five (5) members representing various taxing entities; and

**WHEREAS**, as a taxing unit, the City is entitled to nominate up to five (5) candidates to sit on the Bexar Appraisal District Board of Directors; and

**WHEREAS**, the term of Jim McAden, the current City of San Antonio representative, will expire on December 31, 2005; and

**WHEREAS**, in accordance with the Property Tax Code, Section 6.03, members serve two-year terms beginning on January 1 of even numbered years; and

**WHEREAS**, on October 6, 2005, the City Council approved Resolution No. 2005-40-36 nominating Jim McAden as the City's candidate for election to the Bexar Appraisal District Board of Directors; and

**WHEREAS**, in accordance with the Property Tax Code, the Resolution was submitted to the Chief Appraiser who returned the ballot to the City Council in order to allocate the necessary votes; and

**WHEREAS**, the taxing entities involved must now allocate the number of votes by Resolution and submit the votes on the Official Ballot to the Chief Appraiser; and

**WHEREAS**, the total number of votes allocated to the City of San Antonio is 924, and 834 votes are needed to assure the election of the City's candidate to the Board; **NOW THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** The City of San Antonio, as a taxing entity, now submits this Resolution, along with the Official Ballot with the number of votes, to the Chief Appraiser, who will count the votes and declare the five candidates with the greatest number of votes elected and submit the results to each taxing entity by December 15, 2005. The following represents the voting allocation:
