

AN ORDINANCE 2006-01-05-30

**AUTHORIZING AN AMENDMENT TO MULTIPLE USE AGREEMENTS WITH TxDOT TO RELEASE APPROXIMATELY 96 PARKING SPACES UNDER IH 37 BETWEEN NOLAN AND DAWSON STREETS LOCATED IN DISTRICT 2, FOR USE BY AN ADJACENT PROPOSED COMFORT SUITES HOTEL.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City of San Antonio releases its contractual rights with the Texas Department of Transportation to 96 parking spaces located under Interstate Highway 37 on the east side of downtown between Nolan Street and Dawson Street. The specific 96 spaces are graphically depicted on **Exhibit A**, which is incorporated herein by reference for all purposes as if it were fully set forth.

**SECTION 2.** The City Manager and her designee are further authorized and directed (1) to take all other actions and (2) to execute and deliver on behalf of the City all documents reasonably necessary or convenient to effect the action described in this ordinance.

**SECTION 3.** This ordinance shall become effective January 15, 2006.








