

AN ORDINANCE 2006-01-05-23

AUTHORIZING PAYMENT IN THE AMOUNT OF \$49,000.00 TO THE SAN ANTONIO MOBILITY COALITION, INC. (SAMCO), FOR ANNUAL MEMBERSHIP DUES FOR FEBRUARY 1, 2006 THROUGH JANUARY 31, 2007.

WHEREAS, the San Antonio Mobility Coalition, Inc. (SAMCo), a nonprofit group formed in 2002, facilitates communication between public and private interests working to expedite the Metropolitan Planning Organization (MPO) 25-year Transportation Plan; and

WHEREAS, SAMCo assists the City with identifying, publicizing, and advancing the implementation of mobility solutions for San Antonio that will maintain and improve quality of life, economic growth, and business conditions of the area; and

WHEREAS, SAMCo assists the City in identifying opportunities for increased local, state, and federal funding for transportation projects that will improve the mobility in San Antonio; and

WHEREAS, SAMCo provides a web site with information on transportation issues, a calendar of events and links to other transportation related sites; and

WHEREAS, SAMCo assists the City with its transportation needs, solutions, and funding sources; and

WHEREAS, SAMCo represents the interest of the City and partners regarding transportation funding, (e.g., Federal Highway Administration for Intelligent Enhancement Grants); and

WHEREAS, SAMCo is a valuable source of information and assistance regarding transportation mobility solutions and procedures; and

WHEREAS, SAMCo provides invaluable services to the City by monitoring State and Federal legislative activity on behalf of the City and facilitates the exchange of information to improve the City's transportation mobility solutions; and

WHEREAS, a one-time reduction of thirty percent for the City of San Antonio's annual membership in the San Antonio Mobility Coalition, Inc. was approved by the Executive Committee on October 17, 2005; and

WHEREAS, approval of this Ordinance is a continuation of City Council policy to cooperate in identifying and supporting the implementation of transportation mobility solutions for the San Antonio Metropolitan Area, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following financial adjustments are hereby authorized to effect this ordinance:

a.) Funds for this expenditure are available in Cost Center 8002430001, CITY WIDE ORGANIZATIONAL MEMBERSHIP General Ledger 5203050, Membership Dues and Licenses.


b.) Payment not to exceed \$49,000 is authorized to the San Antonio Mobility Coalition, Inc. and should be encumbered with a purchase order.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The director of finance may, subject to concurrence by the City Manager, or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. The statements set forth in the recitals of this Ordinance are true and correct, and such recitals are incorporated as a part of this Ordinance.


SECTION 4. This ordinance shall be effective on January 15, 2006.


