

AN ORDINANCE 2006-04-20-0498

**AUTHORIZING A TWO MONTH EXTENSION AND EXECUTION OF TWO NO COST CONTRACT AMENDMENTS TO JULY 31, 2006 WITH THE AMERICAN G.I. FORUM--NATIONAL VETERANS OUTREACH PROGRAM (NVOP) IN ORDER TO OPERATE THE NVOP'S RESIDENTIAL CENTERS FOR PERMANENT HOUSING AND TRANSITIONAL HOUSING; APPROVING REVISED BUDGETS; AND AUTHORIZING ALL NECESSARY RELATED DOCUMENTS.**

**WHEREAS**, on May 22, 2003, pursuant to Ordinance No. 97663, the City Council authorized the execution of two delegate agency contracts with the American G. I. Forum – National Veterans Outreach Program (NVOP), in connection with the 2002 Supportive Housing Program; and

**WHEREAS**, the City of San Antonio (City) contracted with the NVOP for the period June 1, 2003 to May 31, 2006 for the NVOP to construct new permanent and transitional housing facilities for homeless veterans, and to provide one year of operation for each of these programs; and

**WHEREAS**, the construction of new permanent and transitional housing facilities and the provision of direct client services was delayed due to difficulties with obtaining building permits, setting up security, and setting up computer network systems; and

**WHEREAS**, the NVOP consequently was unable to complete its scope of work during the term of its delegate agency contracts; and

**WHEREAS**, the City and the NVOP would like to extend the current contract terms from May 31, 2006 to July 31, 2006 at no additional cost to the City, and adjust budget allocation expenditures in order to enable the NVOP to operate the permanent and transitional housing facility programs for one year; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager, or her designee, or the Director of the Department of Community Initiatives is authorized to execute two contract amendments with the American G. I. Forum – National Veterans Outreach Program (NVOP) to extend the term of the contracts at no additional cost to the City from May 31, 2006 to July 31, 2006 in order to operate the NVOP's permanent and transitional housing facility programs. A copy of said contract amendments are attached hereto and incorporated herein for all purposes as Attachment I and Attachment II. The City Manager, or her designee, or the Director of the Department of Community Initiatives is further authorized to execute all necessary related documents.

**SECTION 2.** The revised budget for the “2002 Supportive Housing Program – Permanent Housing Residential Center” and for the “2002 Supportive Housing Program—Transitional Housing Residential Center”, Fund No. 26-054000, Internal Order No. 138000000207, are attached hereto and incorporated herein for all purposes respectively as Attachments III and IV, and are hereby approved.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This ordinance shall be effective on and after April 30, 2006.
