

AN ORDINANCE 2006-05-04-0532

ACCEPTING THE OFFER SUBMITTED BY WHEELED COACH INDUSTRIES, INC. TO PROVIDE THE FIRE DEPARTMENT WITH ELEVEN TYPE I AMBULANCES FOR A TOTAL COST OF \$922,500.00, OF WHICH \$660,000.00 WILL BE FUNDED FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND, AND \$262,500.00 WILL BE FUNDED FROM THE EMERGENCY MEDICAL SERVICES FUND.

WHEREAS, offers were submitted through the Texas Local Government Purchasing Cooperative (a.k.a. the "Buyboard") by Wheeled Coach Industries, Inc. to provide the Fire Department with eleven Type I ambulances for a total amount of \$922,500.00; and

WHEREAS, this purchase meets the requirements under the terms of the Texas Local Government Purchasing Cooperative agreement adopted by the City of San Antonio by Ordinance No. 97097 on January 30, 2003; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer from Wheeled Coach Industries, Inc. to provide the Fire Department with eleven Type I ambulances for a total amount of \$922,500.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. A copy of the bid tabulation sheet is attached hereto and incorporated herein for all purposes as Exhibit A. A copy of the contract is available for inspection in the offices of the Purchasing and General Services Department.

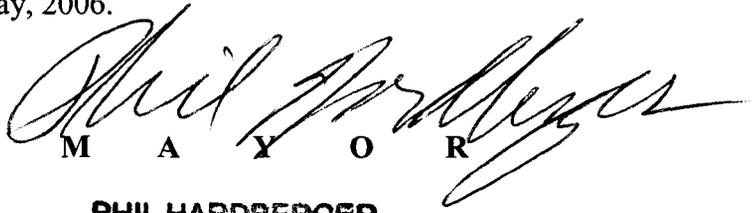
SECTION 2. The amount of \$660,000.00 will be encumbered in Fund 72-001000, Equipment Renewal and Replacement Fund, in GL 5501050, entitled, Cap <\$5,000 M & E Auto, in Cost Center 1503200001, and is authorized to be made payable to Wheeled Coach Industries, Inc. All expenditures will be in accordance with the FY 2005-2006 budget approved by City Council.

SECTION 3. The amount of \$262,500.00 has been encumbered in Fund 29-030000, Emergency Medical Services Fund, in GL 5709090, entitled M & E Auto, in Cost Center 2005010001, and is authorized to be made payable to Wheeled Coach Industries, Inc. All expenditures will be in accordance with the FY 2005-2006 budget approved by City Council.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Acting Director of Finance, City of San Antonio. The Acting Director may, subject to concurrence by the City Manager, or the City Manager's designee, correct allocations to specific Cost Centers and Fund Numbers as necessary to carry out the purpose of this Ordinance.

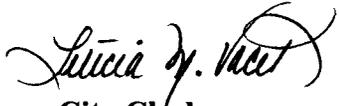
SECTION 5. This ordinance shall take effect May 14, 2006.
