

AN ORDINANCE **98851**

**AUTHORIZING FUNDS IN THE AMOUNT OF \$1,349.08 FROM GENERAL OBLIGATIONS OF THE CITY PAYABLE TO DAVIDSON & TROILO, P.C., FOR LEGAL SERVICES NECESSARY TO THE REAL ESTATE ACQUISITIONS FOR THE FOLLOWING APPROVED CITY PROJECTS: BABCOCK ROAD/LEON CREEK IMPROVEMENTS – HAUSMAN TO DEZAVALA PROJECT, LOCATED IN COUNCIL DISTRICT 8; BITTERS ROAD – WEST AVENUE TO HEIMER MPO PROJECT, LOCATED IN COUNCIL DISTRICT 9 AND THE SOUTHCROSS BLVD. – NEW BRAUNFELS TO PRESA MPO PROJECT, LOCATED IN COUNCIL DISTRICT 3; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.**

**WHEREAS**, legal services were required for the Babcock Road/Leon Creek Improvements project, Bitters Road – West Avenue to Heimer (MPO) project, and the Southcross Blvd. – New Braunfels to Presa (MPO) project; and

**WHEREAS**, charges for such services are reasonable and necessary expenses relating to the above-mentioned projects; **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The total amount of \$1,349.08 is hereby authorized to be encumbered from the financial adjustments stated below and made payable to **DAVIDSON & TROILO, P.C., 7550 West IH-10, Suite 800, San Antonio, Texas, 78229-5815** for the Projects indicated.

a) The budget in fund 45-468014, 1994 General Obligation Drainage Improvements Bonds, Sold in 1998A, shall be revised by increasing index code 917526, entitled Transfer to 45-746013, in the amount of \$162.00. The amount of \$162.00 is authorized to be transferred from Fund 45-468014 to Fund 45-746013.

b) The budget in fund 45-746000, 1987 General Obligation Drainage Improvements Bonds, Sold in 1994, shall be revised by increasing index code 115204, entitled Transfer from 45-468014 (45-746013), in the amount of \$162.00.

c) The amount of \$162.00 is appropriated in fund 45-746013, 1987 General Obligation Drainage Improvements Bonds, Sold in 1994, in index code 632273, entitled Legal Fees, and is authorized to be encumbered and made payable to Davidson & Troilo, P.C., for legal services in connection with the Babcock Road/Leon Creek Improvements-Hausman To DeZavala Project .

d) The budget in Fund 43-070095, Certificates of Obligation 2000A MPO, shall be revised by reducing Index Code 509315, entitled Unallocated Appropriations-Proceeds, by the amount of \$1,061.08.

e) The amount of \$1,061.08 is appropriated in fund 43-070004, 2000A Certificates Of Obligation MPO, in index code 617365, entitled Legal Fees, and is authorized to be encumbered and made payable to Davidson & Troilo, P.C. for legal services in connection with the Bitters Road-West Avenue To Heimer (MPO) Project.

f) The budget in fund 43-152095, 2002 MPO Certificates of Obligation, shall be revised by reducing index code 751479, entitled Unallocated Appropriations, by the amount of \$126.00.

g) The amount of \$126.00 is appropriated in fund 43-152015, 2002 MPO Certificates of Obligation, in index code 933044, entitled Transfer to 45-979069. The amount of \$126.00 is authorized to be transferred from fund 43-152015 to fund 45-979069.

h) The budget in fund 45-979000, 1999 Street Improvements, shall be revised by increasing index code 132308, entitled Trf Fr 43-152015 (45-979069) Southcross, by the amount of \$126.00

i) The amount of \$126.00 is appropriated in fund 45-979069, 1999 Street Improvements, in Index Code 618603, entitled Legal Fees, and is authorized to be encumbered and made payable to Davidson and Troilo, P.C. for Legal Services in connection with the Southcross Blvd-New Braunfels to Presa (MPO) Project.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This Ordinance shall be effective on the 29<sup>th</sup> day of February, 2004.


