

AN ORDINANCE **9 9 2 3 0**

ACCEPTING THE LOW RESPONSIVE BID SUBMITTED BY DONSAN CONSTRUCTION, LLC, (MBE) TO PROVIDE THE CITY OF SAN ANTONIO PARKS AND RECREATION DEPARTMENT WITH SPRINGTIME PARK IMPROVEMENTS FOR A TOTAL AMOUNT OF \$102,550.00.

WHEREAS, bids were submitted to provide the City of San Antonio Parks and Recreation Department with Springtime park improvements; and

WHEREAS, the low bid was submitted by Donsan Construction, LLC, (MBE) for a total amount of \$102,550.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Donsan Construction, LLC, (MBE) to provide the City of San Antonio Parks and Recreation Department with Springtime park improvements for a total amount of \$102,550.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits and insurance certificates. All other bids will be considered rejected upon the successful bidder's completion of all conditions precedent to award or the expiration of sixty days from the effective date hereof, whichever occurs first. Attached hereto and incorporated herein for all purposes as Attachment A is the bid and bid tabulation sheet.

SECTION 2. The budget and encumbrance in fund 40-028002, Other Capital Projects, One-Time Council Projects District 8, shall be revised by reducing document PO96897B, index code 759241, entitled Park Construction Crew City Forces, by the amount of \$3,798.69.

SECTION 3. The budget and encumbrance in fund 40-028002, Other Capital Projects, One-Time Council Projects District 8, shall be revised by reducing document PS97671, index code 759241, entitled Park Construction Crew City Forces, by the amount of \$98,751.31.

SECTION 4. The amount of \$102,550.00 is appropriated in fund 40-028002, Other Capital Projects, One-Time Council Projects District 8, in index code 756502, entitled Construction Contract, and is authorized to be encumbered and made payable to Donsan Construction, LLC, in connection with the Springtime Park (Oxbow/Babcock North Park) Project.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This ordinance shall take effect June 6th, 2004.
