

AN ORDINANCE

AMENDING THE PROFESSIONAL SERVICES AGREEMENT AND AUTHORIZING PAYMENT OF AN AMOUNT NOT TO EXCEED \$18,955.00 FROM CERTIFICATES OF OBLIGATION TO TURNER, COLLIE & BRADEN, INC. FOR ADDITIONAL PROFESSIONAL SERVICES IN CONNECTION WITH THE BITTERS ROAD - WEST AVENUE TO HEIMER PROJECT, LOCATED IN COUNCIL DISTRICT 9; REVISING THE PROJECT BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The professional services contract with **Turner, Collie & Braden, Inc.** authorized pursuant to Ordinance Number 87176, passed and approved on January 8, 1998, in the amount of \$75,000.00 is amended in accordance herewith and additional funds in an amount not to exceed \$18,955.00, payable to **Turner, Collie & Braden, Inc.** for additional engineering services in connection with the Bitters Road-West Ave. to Heimer Project, are hereby authorized. A copy of the proposal is attached hereto and incorporated herein for all purposes as **Attachment I.**

SECTION 2. The budget in fund 43-172095, 2002 Street Improvements, shall be revised by reducing Index Code 753046, entitled Unallocated Appropriations, by the amount of \$18,954.70.

SECTION 3. The amount of \$18,954.70 is appropriated in fund 43-172034, 2002 Street Improvements, in Index Code 938860, entitled Trf to 43-070004 Bitters. The amount of \$18,954.70 is authorized to be transferred from Fund 43-172034 to Fund 43-070004.

SECTION 4. The budget in Fund 43-070000, Certificates of Obligation 2000A MPO, shall be revised by increasing Index Code 137380, entitled "Trf Fr 43-172034 (43-070004)", in the amount of \$18,954.70.

SECTION 5. The amount of \$18,954.70 is appropriated in Fund 43-070004, Certificates of Obligation 2000A MPO, in Index Code 617415, entitled Engineering Contract, and is authorized to be encumbered and made payable to **Turner Collie & Braden, Inc.**, in connection with the Bitters Road from West Avenue to Heimer Road (MPO) Project.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


SECTION 7. This ordinance shall be effective on the 8th day of August, 2004.
