

AN ORDINANCE 99683

AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE SAN ANTONIO INDEPENDENT SCHOOL DISTRICT (SAISD) IN THE AMOUNT OF \$13,780.00 TO IMPLEMENT THE URBAN smARTS PROGRAM ADMINISTERED BY THE CITY OF SAN ANTONIO, DEPARTMENT OF COMMUNITY INITIATIVES, AT ONE SAN ANTONIO INDEPENDENT SCHOOL DISTRICT SCHOOL DURING THE PERIOD SEPTEMBER 13, 2004 THROUGH JUNE 30, 2005; ESTABLISHING A FUND; ADOPTING A BUDGET AND APPROVING A PERSONNEL COMPLEMENT.

WHEREAS, the Urban smARTS Program has provided arts enrichment and early intervention services to elementary and middle school students since 1993 and has attempted to divert them from the juvenile justice system, improve social behavior and social skills, improve academic performance and commitment to school, develop art skills, provide opportunities for artistic performances and exhibitions, and provide an after-school safe haven; and

WHEREAS, the contract in the amount of \$13,780.00 with the San Antonio Independent School District (SAISD) will be used to pay for two artists and one art assistant at one SAISD middle school and for curriculum and supplies; and

WHEREAS, the Urban smARTS Program proposes to serve eighty students at one school with funding from the SAISD during FY 2004-2005; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, or the Director of the Department of Community Initiatives are authorized to execute a contract with the San Antonio Independent School District in the amount of \$13,780.00 to implement the Urban smARTs Program at Pickett Academy Middle School during the period September 13, 2004 through June 30, 2005. A copy of the contract, in substantially final form, is attached hereto and incorporated herein as Attachment I.

SECTION 2. Fund No. 26-012273 entitled: "Urban smARTS 05 – San Antonio Independent School District" is designated for use in accounting for said program, and the sum of \$13,780.00 is appropriated in said fund and adopted as set out in the budget, attached hereto and incorporated herein for all purposes as Attachment II.

SECTION 3. The Personnel Complement, attached hereto and incorporated herein for all purposes as Attachment III, is approved.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall become effective on and after September 19, 2004.




