

AN ORDINANCE

2007-09-20-1017

AUTHORIZING A ONE-YEAR EXTENSION FOR THE PERIOD OF OCTOBER 1, 2007, TO SEPTEMBER 30, 2008, OF THE SAN ANTONIO FIRE DEPARTMENT PERSONAL PROTECTIVE CLOTHING CONTRACT WITH TOTAL FIRE GROUP, INC.

WHEREAS, pursuant to Ordinance No. 98000, passed and approved on August 14, 2003, the City entered into an agreement with Total Fire Group, Inc. to provide personal protective clothing to the San Antonio Fire Department; and

WHEREAS, said agreement provided for an initial term ending September 30, 2005, and provided for three one-year extensions at the City's option; and

WHEREAS, the City has previously extended said agreement on two occasions; and

WHEREAS, the City wishes to extend said agreement for one more year, for the period commencing October 1, 2007, and ending September 30, 2008; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee are hereby authorized to execute a one-year extension to the personal protective clothing agreement with Total Fire Group, Inc. that was executed pursuant to Ordinance No. 98000. A copy of the contract extension is attached hereto and incorporated herein, and the terms of the extension are hereby approved.

SECTION 2. Funding for this ordinance is contingent upon approval of the FY 2008 budget for Fund 11001000 (General Fund), Cost Centers 2001060002 (Bunker Gear) and 2001060003 (Cleaning and Repair), General Ledger 5201040 (Fees to Professional Contractors). Payment not to exceed the budgeted amount is authorized to Total Fire Group and should be encumbered with a purchase order.

SECTION 3. The financial allocations in this ordinance are subject to approval by the Director of Finance. The Director may, subject to concurrence by the City Manager or the City Manager's

designee, correct allocations to specific cost centers, WBS elements, internal orders, general ledger accounts, and funds as necessary to carry out the purposes of this ordinance.

SECTION 4. This ordinance shall take effect ten days from the date of passage.

**ONE YEAR EXTENSION (October 1, 2007 to September 30, 2008) and
AMENDMENTS TO THE PERSONAL PROTECTIVE CLOTHING
CONTRACT**

This first extension to the Personal Protective Clothing Contract, extending from October 1, 2007 until September 30, 2008, is entered into by and between the CITY OF SAN ANTONIO (hereinafter referred to as "CITY"), a Texas municipal corporation, acting by and through the Fire Chief, Charles N. Hood and THE TOTAL FIRE GROUP. (Hereinafter referred to as "VENDOR"), acting by and through Mary Grilliot, President and is as follows:

I.

Pursuant to the provision of Section XXVII. AMENDMENTS of the PERSONAL PROTECTIVE CLOTHING CONTRACT (hereinafter referred to as "CONTRACT"), CITY and VENDOR may amend said CONTRACT by mutual consent of the parties. CITY and VENDOR hereby agree to amend Section VI. Costs and Invoicing, Subsection 6.1;


