

AN ORDINANCE

AUTHORIZING A FUNDING AGREEMENT AND ACCEPTING \$31,086.35 FROM GOODWILL INDUSTRIES OF SAN ANTONIO, VISTANA, LTD., AND MPL FAMILY LIMITED PARTNERSHIP TO PROVIDE FOR INFRASTRUCTURE IMPROVEMENTS ON LAREDO STREET BETWEEN DOLOROSA STREET AND W. COMMERCE STREET LOCATED IN COUNCIL DISTRICT 1.

WHEREAS, Laredo Street between Dolorosa Street and W. Commerce Street is a single lane one-way roadway that allows traffic traveling westbound on Commerce Street the ability to turn left onto Laredo Street and then left onto Dolorosa Street and Laredo Street between W. Commerce and Houston Street is a two lane two-way roadway; and

WHEREAS, **Goodwill** is adjacent to the Laredo Street segment that is a one-way roadway, **Vistana** is adjacent to the Laredo Street segment that is a two-way roadway, and **MPL** fronts Dolorosa, and each entity is interested in improving access to their business; and

WHEREAS, these entities have asked the City to convert Laredo Street between Dolorosa Street and W. Commerce Street from a one-way street to a two-way street and have agreed to fund \$31,086.35 of the \$90,000.00 total costs associated with this improvement; and

WHEREAS, the City has agreed to fund the completion of this conversion in the amount of \$58,913.65 from the 2007 Downtown Transportation Infrastructure Improvements Bond; and

WHEREAS, this Ordinance will authorize the execution of a Funding Agreement and accept funds in the amount of \$31,086.35 from **Goodwill**, **Vistana**, and **MPL** to allow the City to complete the infrastructure improvements on Laredo Street; and

WHEREAS, this is a one-time capital improvement expenditure in the amount of \$90,000.00 of which \$58,913.65 is available from the FY 2007 Downtown Transportation Infrastructure Bond;
NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Funding Agreement and accept funds in the amount of \$31,086.35 from **Goodwill**, **Vistana**, and **MPL** to allow the City to complete the infrastructure improvements on Laredo Street.

SECTION 2. The following financial adjustments are hereby approved:

- a) Funds are authorized to be received from Goodwill Industries of San Antonio to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00013, Downtown Transportation Infrastructure, and the budget shall be revised by increasing WBS element 40-00013-90-14, Goodwill Industries Contribution, SAP GL 4502280, Contribution from other Agencies, by the amount of \$31,086.35.

- b) The amount of \$31,086.35 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00013, Downtown Transportation Infrastructure, SAP WBS Element 40-00013-05-02-01-16, Laredo Two-Way Conversion, SAP GL Account 5201140, Construction Costs.
- c) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.




